WHEREAS, Annandale Properties, L.P., a Mississippi limited partnership, is the successor to Annandale Development Company as the Declarant under the terms and provisions of the Declaration and said Supplementary Declarations, and is the owner of certain lots and real property and is a Class B Member of the Association; and

Subparagraphs (a) and (b) of Paragraph 9 are hereby amended as follows:

- (a) that portion of said annual maintenance assessment which is attributable to Class A membership shall not exceed One Hundred Eighty Dollars (\$180.00) per annum, plus whatever additions to said sum of \$180.00 which, in accordance with the provisions of the Declaration, may be imposed with respect to the properties now or hereinafter set aside as commons areas;
- (b) that portion of said annual maintenance assessment which is attributable to the Additional Services
